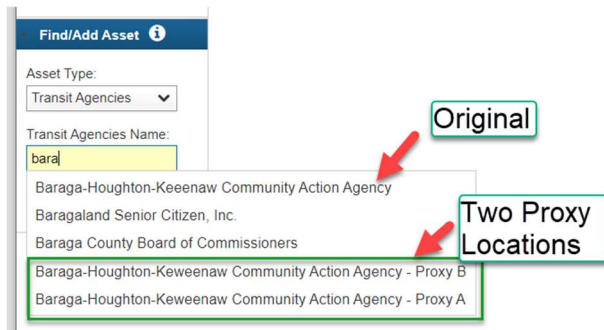


## Proxy Transit Agency Locations
